The Federal Energy Regulatory Commission (Commission), in the above-referenced matters, issued an Order Approving Uncontested Settlement And Denying Rehearing (Order) on March 21, 2008 (122 FERC ¶ 61,257). In that Order, the Commission approved the creation of an Advisory Committee of the Organization of PJM States, Inc.
